1. REVIEW OF PREVIOUS MINUTES OF MEETING

The minutes of previous meeting held on 16.07.2016 and the proposed actions taken thereupon were reviewed thoroughly and found satisfactory to great extent.

2. DISPOSAL OF OLD/ TARGET CASES

Disposal of old / target cases was discussed at length. The participants made available the figure of old /target cases pending and disposed of by them. But the Chair showed his dissatisfaction upon disposal of old/target cases. The Chair stressed upon the participants for disposal of old/ target cases in parallel to the newly instituted cases also for better results in DPEP. The Chair also directed the participants to avoid un-necessary adjournments in the cases. The

3. CONSIGNMENT OF RECORD

The Chair emphasized upon all the judicial officers that moharrirs of the courts be directed to ensure timely consignment of disposed of cases which was agreed upon by all.

The Chair showed his satisfaction upon the punctuality observed by the judicial officers at present. The Chair directed the participants that attendance of ministerial staff be also checked properly and regularly.

5. EQUALIZATION OF PENDENCY

Equalization of the pendency of cases was also discussed and the participants showed their satisfaction upon the present scheme of distribution of cases. The Chair also discussed about the target cases of the court of Civil Judge-VI, Nowshera and its distribution as the Judicial Officer is on leave for 03 months.

6. ANY OTHER MATTER

The Chair also guided all the judicial officers of the District, to maintain good conduct and behavior but at the same time to avoid the habit of unnecessary entertaining the guests in their chambers to protect the dignity and honour of the officer.
