Meeting formally commenced with the recitation of the Holy Quran. Agenda items of the meeting were as follows:

2. Disposal of old / target cases.

**1. REVIEW OF PREVIOUS MINUTES OF MEETING**

The minutes of meeting held on 06.06.2016 and the proposed actions taken thereupon were reviewed thoroughly and found satisfactory to great extent.

**2. DISPOSAL OF OLD/ TARGET CASES**

Disposal of old / target cases was discussed at length. The data of old/ target cases were furnished by the participants. At the Sessions level no old/ target case was found pending at present whereas 16 target cases are pending before the court of learned Senior Civil Judge, Nowshera, 24 target cases before the learned Civil Judge-VI, Nowshera, 17 before the court of learned Civil Judge-II while 05 target cases are pending before the court of learned Civil Judge-VII, Nowshera. Learned Judicial Magistrate-I and II Nowshera as well as learned Judge Family Court have got no target case.

Although the chair emphasized upon disposal of old/ target cases but showed his satisfaction upon the present position. The Chair stressed upon the participants for disposal of old/ target cases in parallel to the newly instituted also for better results in DPEP. Moreover, advised for avoiding un-necessary adjournments in the cases.

### **3. CONSIGNMENT OF RECORD**

The Chair emphasized upon all the judicial officers that moharrirs of the courts be directed to ensure timely consignment of disposed of cases.

### **4. PUNCTUALITY**

The Chair once again emphasized upon punctuality. The Chair further directed the participants that attendance of ministerial staff be also checked properly.

### **5. EQUALIZATION OF PENDENCY**

Equalization of the pendency of cases was also discussed in detail. The pendency of cases of all the courts at Sessions level was inquired by the Chair and it was discussed that pendency has been much equalized and streamlined for the purpose that no court be overburdened.
