The meeting was formally started with the Recitation of the Holy Quran. Points on agenda, previously circulated vide letter No.1568/SCJ/JM/Nowshera Dated Nowshera 07.09.2015 were tabled for

In pursuance of the directions of the honorable District & Sessions Judge, Nowshera, all the Judicial Officers, attending the meeting, were fully prepared with facts, figures and other necessary information regarding the items on schedule.

AGENDA ITEM NO.1 REVIEW OF PREVIOUS MEETING:

The minutes of meeting held on 07th July, 2015 and the proposed action taken thereupon were reviewed thoroughly and found satisfactory to great extent. The Chair remembered that we are part of a single team and responsible for one work individually as well as collectively. Administration of justice is a sacred cause and everyone is requested to contribute with devotion.

AGENDA ITEM NO.2 DISPOSAL OF OLD/TARGET & BACKLOG CASES/DPEP.

This agenda item was thoroughly discussed by the Chair with all the participants. The Chair inquired about the disposal of cases by each Court and noted down the figures provided by them. The Chair appreciated the output given by the participants. However, at the same time also emphasized the early disposal of the all the target cases especially, to end the agonies of long waiting litigants. Similarly, the figures of backlog cases were also discussed and the Chair stressed upon equal attention to be given by the Judicial Officers to these cases as well so that they may not become targets in future. The Chair advised the judicial Officers to develop the habit of preparing the case one day before its hearing on the next date in the Court in order to grasp the matter in issue which will help in quick disposal of the cases as the Chair guided that many cases involve only simple matter in issue which requires attention of presiding officer. All the participants assured the Chair to dispose of the cases as per DPEP.

AGENDA ITEM NO.3 CONSIGNMENT TO THE RECORD ROOM.

The Chair once again like in the previous meeting in lines with the judgment of august Supreme Court of Pakistan emphasized upon timely writing and timely consignment of the judicial record to the record room so that the public litigants may not suffer for the unnecessary delay.

AGENDA ITEM NO.4 PUNCTUALITY.

The Chair while stressing upon this item said that ' A judge should be God fearing'. That the judicial Officer should adopt the habit of punctuality in his life and that each judicial officer should come to the Court in time. So that the affairs of the Court could timely be managed. In response, all the participants committed to come well in time.

AGENDA ITEM NO.5 EQUALIZATION OF PENDENCY.

The Chair inquired about the pendency of each Court and the number of target cases with them. At this juncture, the honorable Chair felt the heavy work load upon Mr. Abdul Jabbar Khan, the learned Additional Sessions Judge-III, Nowshera who has got huge pendency. So the Chair agreed soon to take suitable steps in this respect. So that no Court be overburdened more than its natural capacity.

AGENDA ITEM NO.6 SUMMONING OF PWS.

Some of the participants made a complaint about the attendance of PWs in criminal cases. So the Chair ensured to take the matter in the forthcoming Criminal Justice Co-ordination Committee and get away with this problem.

AGENDA ITEM NO.7 ANY OTHER MATTER.

While discussing this subject agenda, all the participants showed contentment and did not point out any other problem facing to them at present.
